SFCASA's 336 volunteers provided one-on-one mentoring and advocacy to 341 foster youth. CASA volunteers are sworn officers of the court, trained to mentor and advocate for the best interests of foster youth in the dependency system. They advocate through court reports submitted directly to the judge overseeing the case, as well as working directly with schools, social workers and healthcare providers. SFCASA implemented a first-of-its-kind impact measurement and learning system to more fully understand the progress of each youth and the impact of its advocacy and mentoring program overall.

Launched in July 2017, San Francisco CASA's Court Dog program provides a highly trained facility dog in the courtroom during Family Court proceedings involving foster youth and their families, helping to deescalate tensions and create a feeling of calm. "Nemo," a gentle Labrador Retriever, was expertly trained by Canine Companions for Independence (CCI) and is partnered with Nemo's facilitator and co-facilitator, both of whom completed an intensive training at CCI.
